Monthly Lesson Fees

Group Lesson – 1 hour weekly, month to month **\$ 77**

Beginner / Hoop Classes 4 lessons per month [4 hours]

Additional student from same family \$42

Performance team 2 lessons per month [2 hours] **\$56**

Additional student from same family \$21

Individual Member monthly fee [regardless of total hours of instruction] **\$ 47**

Coach's private lesson fee paid directly to Coach, and amount varies by coach.

Individual members are those taking only private lessons, no team.

Additional student from same family \$12

Fees are non-refundable. Fees are due the first lesson of each month. After the first lesson, a \$15 late fee is incurred per student. Monthly fees cannot be prorated due to student absences. Coach will make up missed material in future lessons. Months with fewer than 4 scheduled lessons due to holidays or extreme weather will have additional lessons scheduled by the coach to complete the 4 per month.

Costs through the season

USTA annual membership dues

Required at first class registration each season, per twirler, starts at: **\$10**

correct size and style, prices start at: **\$29**

Corps Fee 2nd year+ members, Non-refundable; annual. **\$75 per family**

Used for administrative costs, i.e., storage, facilities, notices, supplies, fundraising, corps costuming, props, etc. OR your family may seek an outside donation of \$75 or greater to be collected by September 30 (may come from a business sponsorship, a matching donation program through some employers, etc.)

All Corps families are required to participate each season in corps fundraisers, for example staffing our snack shop at Alaska Sled Dog Racing Association [ASDRA] twice in a season, staffing a water station during a race, or other corps fundraiser as named by Club.

Some twirlers may choose to participate in competitions, locally or out of state, and those costs may include travel, registration or entry costs, additional costuming, lodging and meals during the event, etc. Fundraisers must be corps- approved and may be used to offset some or all costs.
